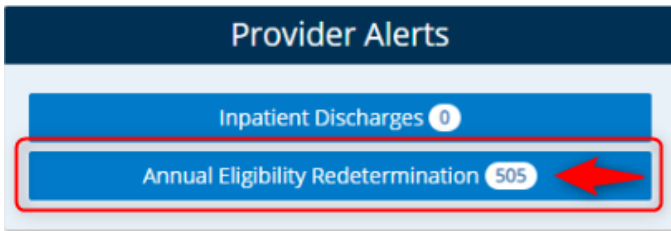

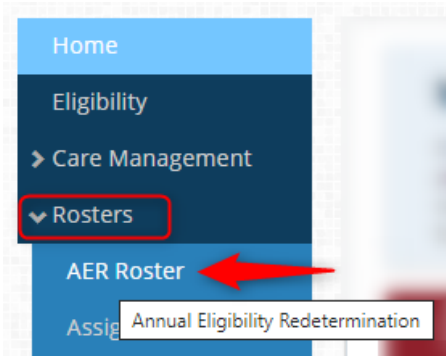

- The Annual Eligibility Renewal alert lets you know how many of your **assigned Members** need to submit their Medi-Cal Renewal packets.
- Clicking on the alert will direct you to the AER Rosters with specific Member contact information

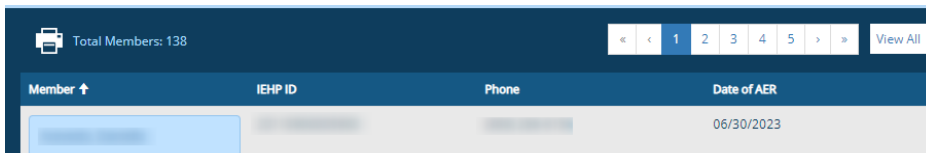
AER Roster



- AER Rosters are also available under the Rosters tab
- To prevent losing assigned Members:
 - ✓ Consider outreaching to Members on the roster and ask, “**Have you received your YELLOW Medi-Cal Renewal Packet Yet?**”
 - ✓ If they need assistance with their packet, they can call **IEHP Eligibility Renewal Support Team at 1-888-860-1296**
 - ✓ If they have **NOT** received it, advise them to call their county or IEHP to update their contact information:

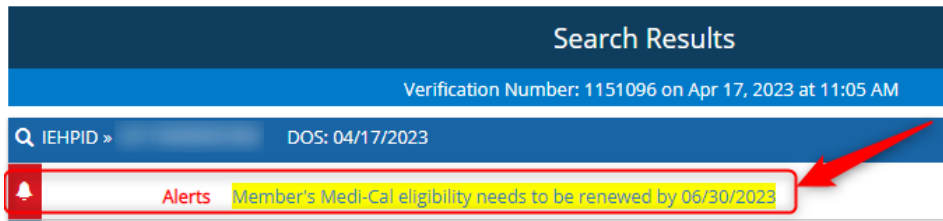
Annual Eligibility Redetermination (AER) Roster

Members on this roster are due for Annual Eligibility Redetermination (AER). If Members do not complete their annual eligibility redetermination by the date indicated on the roster, the Member will be disenrolled from Medi-Cal and no longer assigned to your practice through IEHP. Members have **90 days** after the Annual Eligibility Redetermination date to cure their eligibility and be reinstated. To prevent a disruption in eligibility, we appreciate your support in advising Members of the importance of keeping their contact information current and completing the AER process. Eligibility Alert



- When verifying Member eligibility, an alert will appear if a Member's Medi-Cal Eligibility needs to be renewed.
- ✓ Make a note that their Medi-Cal Eligibility must be renewed.
- ✓ Encourage front office staff to ask Members as they check in, **"Have you received your **YELLOW** Medi-Cal Renewal Packet Yet?"**
- ✓ If they need assistance with their packet, they can call **IEHP Eligibility Renewal Support Team at 1-888-860-1296**
- ✓ If they have **NOT** received it, advise them to call their county or IEHP to update their contact information:

Riverside County – 1-877-410-8827

★ **Remind Members if they miss their renewal due date, they have 90 days after the date to submit their forms and renew eligibility.**
