Subject: **EVV CODE Changes Effective April 20, 2023**

The California Electronic Visit Verification (CalEVV) program has **two changes effective April 20, 2023:**

What is changing?

1. CalEVV is adding the following new codes to the EVV system.

2. CalEVV Services Code Descriptions have been updated and new service codes have been added for the following programs:

- California Children’s Services
- Managed Care Plan/Fee-for-Service
- Home and Community Based Alternative Services
- Community Based Adult Services
- Medi-Cal Waiver Program
- In-Home Supportive Services

What are the impacts?

- Provider office staff reviewing and creating client-payer records and visit records, including running reports, in CalEVV and the Aggregator will see the revised service descriptions.
- Service Providers and caregivers logging visits in CalEVV will have new service descriptions to choose from.
- Therapy and infusions codes will be available as of April 19.
- Underlying HCPCS (billing) codes associated with the prior payer and service descriptions are the same; there are no impacts to these two processes.
- All existing client-payer records and visit records in CalEVV, including those received from Alternate EVV systems, will be converted to reflect the new service code descriptions. The service descriptions will be the exact description that providers will see when they login to the Sandata solution which also includes the HCPCS code.
