IEHP is participating in California’s Health Homes Program as defined by section 2703 of the Affordable Care Act. Section 2703 allows States to create Medicaid health homes which provide supplemental services that coordinate the full range of physical health, behavioral health, and community-based long-term services and supports needed by people with chronic conditions. IEHP’s implementation of the Health Homes Program will go live **January 1, 2019**.
