## MANAGED CARE ENROLLMENT OVERVIEW

IEHP is one of the top 10 largest Medicaid health plans and the largest not-for-profit Medicare-Medicaid plan in the country. It is the largest Local Initiative plan in the Inland Empire region, serving more than 90% of the Medi-Cal managed care market compared to its commercial counterpart, Molina Healthcare.

## ACCREDITATION AND ACHIEVEMENTS

- In 2000, IEHP was the first Medicaid health plan in California to earn NCQA Accreditation for Medi-Cal. Its accreditation has continued to be renewed.
- IEHP received the 2020 Health Equity Award for its ability to engage and connect with members via text message during Governor Newsom's social isolation order during the COVID-19 pandemic. The award was given by mPulse Mobile, a leader in conversational AI solutions for health care.
- IEHP received a 96.4% provider satisfaction score for 2021, placing the health plan in the 99th percentile for provider satisfaction nationwide.
- In 2021, IEHP received the prestigious Innovation Award from the California Department of Health Care Services (DHCS) for their innovative Medi-Cal Primary Care Physician Auto-Assignment Redesign. This was the fifth time the health plan has received this honor—more times than any other health plan in California. Prior recognitions include utilizing location intelligence to reach members (2020), creating the IEHP Housing Initiative (2018), developing Behavioral Health Integration Complex Care Initiative (2017), and organizing the Transitional Care Project (2015).
- IEHP ranked #15 on the 2022 Best Workplaces in Health Care™ nationwide list. This prestigious award reaffirms what the company's annual survey revealed: 92% of the employee respondents believe IEHP is a great place to work.
