Final Data Submission Deadline is April 1, 2024

Inland Empire Health Plan (IEHP) would like to advise that we are aware of a cybersecurity issue that occurred through Change Healthcare (a software and data analytics subsidiary of UnitedHealth Group's Optum unit), on Feb. 21, 2024, that resulted in nationwide product outages, including clearinghouse functions, impacting payers, providers, and pharmacies.


Change Healthcare's outage has impacted services for some of our Providers and Independent Physician Associations (IPAs). We recognize that this situation is disruptive and are working quickly to minimize the disruption and support our Members and Providers.

## <u>IMPORTANT</u> – ENCOUNTER DATA SUBMISSION DEADLINES FOR 2023 GLOBAL QUALITY P4P PROGRAM

At this time, IEHP <u>will not</u> be extending the data submission deadline for all encounter data submissions relating to the 2023 Global Quality P4P Program. Encounter data related to the 2023 performance year must be submitted to IEHP no later April 1, 2024.

Primary Care Physicians (PCPs) may submit encounters directly through the IEHP Secure Provider Portal <u>or</u> utilize Office Ally (a free clearinghouse option). Please see below for additional information:

- This should only be used if necessary due to an interruption in your practice's standard encounter reporting process.
